Our Aim

- To create a water catchment (commonly referred to as “watershed”).
- To form and promote Cluster Based Business Organizations (CBBOs) /(FPO)Farmer producer Organization’s
- To setup “KISAN SEVA KENDRA” (Farmer knowledge and grievance seva center) district wise.
- To encourage and train the youth to open agro-products chain shop in order to make them entrepreneurs
- To double the farmers’ income every four years.
- To develop social security & welfare system for farmers by forming an integrated federation.
- Online trading platform for farm goods / accessories.
- Destroying & Eradicating Prosopis Juliflora (Seemai karuvellamaram) and develop a village free of seemai karuvellamaram.
- Mobile vans to propagate various schemes promoted by Central Government and to educate best practices to farmers.
- To adopt a village in each revenue district to promote it as a model village by implementing central government schemes.

- Development of agriculture in hilly and non-irrigated area.
- Arrange agricultural demonstrations, exhibitions, group discussions and farmers' trips.
- Educating farmers to get available subsidies / schemes from both Central & State governments.
- To undertake watershed development.
- Provide adequate training to farmers on cattle farming and dairy farming and poultry related business startup.
- To assist in getting farm/life/health insurance.
- To promote natural farming by conducting training for regenerative agriculture practices on farms.
- Provide adequate training to fishermen on new technologies and business opportunities in fisheries by selecting fishermen's villages.
- Publication of monthly magazine (NAVEENA VIVASAYI) in regional language TAMIL.
- To Select best 5 farmers every year and award them with the title " Unavalikkum Uzhavan "(உணவளிக்கும் உழவன்).
